This is to certify that we M/s. M. Alagar & Associates, Firm of Company Secretaries in Practice have verified the resolutions passed by members through electronic voting through e-mail at the 89th Annual General Meeting (**AGM**) of **Kothari Safe Deposits Limited (Company)** held on Friday, July 26, 2024 at 03:00 PM held through Video Conferencing ("**VC**")/ Other Audio Visual Means ("**OAVM**") and based on the documents and records produced before us, we hereby certify as follows;

The Notice was also published in "**Business Standard**" (English) and "**Makkal Kural**" (Tamil) on July 03, 2024.
- (iii) The members of the Company holding shares as on the "**Cut-off**" date (i.e. on Monday, July 22, 2024) have cast their votes through e-mail facility provided by the Company to their designated e-mail address kotharisafedeposits@gmail.com.
- (iv) 11 members of the Company holding **6,20,889** Equity Shares participated in the AGM through VC/ OAVM and 11 members of the company holding **6,20,349** Equity Shares voted through email for the items contained in the notice of the 89th AGM. The emails of the members voted were verified in our presence and reconciled with the records maintained by the Registrar and Transfer Agents of the Company, Cameo Corporate Services Limited.
